**SUBJECT: Agreement with DBA for J.A. Roberts Subdivision Roadway Improvement Work**

**RECOMMENDATION**

Approve the contract with DBA Construction Inc., through a Cooperative Purchasing Agreement based on the City of Scottsdale Job Order Contract for paving and concrete work in the J.A. Roberts Subdivision at a cost not to exceed \$250,000 plus applicable taxes and authorize the Mayor to sign the necessary contract documents.

**DISCUSSION**

On 11/14/2016 the City Council approved the FY 2016-17 financing package for the Street Work Program and the utilization of an alternative purchasing process which includes the use of Cooperative Purchasing Agreements with other agencies such as Pinal County for materials as well as the Pinal County IGA for equipment and personnel.

DBA Construction Inc., has a Job Order Contract (JOC) with the City of Scottsdale to perform this type of work. The contract allows other communities to utilize the contract. Per the City of Coolidge Procurement Code Section 9. Utilization of Bids from other Government Agencies the City can utilize another agencies contract prices that have been acquired through like procedures. Staff is requesting that we utilize the City of Scottsdale JOC contract for DBA Construction Inc., to complete the drainage and paving work in accordance with their proposal and the City of Coolidge Cooperative Purchasing Agreement thereto in an amount not to exceed \$250,000, plus applicable taxes.

DBA Construction is the firm that was responsible for completing the work on Main Street north of Pinkley Avenue and on Vah Ki Inn Road. Staff has been very pleased with the work performed by DBA in the past.
